- E. ALL ASSOCIATES **MUST** SUBMIT A VALID CREDIT CARD ON, WHICH ANY AMOUNTS NOT PAID AFTER 60 DAYS, WILL BE CHARGED TO. NO ASSOCIATE ACCOUNT NUMBERS WILL BE ASSIGNED UNTIL SUCH CREDIT CARD NUMBER IS RECEIVED IN THE OFFICE.
