- C. ALL SOCIAL MEMBERS ARE REMINDED THAT ANY POOL GUESTS THAT ARE NOT PART OF THEIR IMMEDIATE FAMILY ARE SUBJECT TO THE POOL GUEST FEE. PLEASE REGISTER YOUR GUEST AT THE CONCESSION.
- D. ALL SOCIAL MEMBERSHIPS **MUST** SUBMIT A VALID CREDIT CARD IN WHICH AMOUNTS NOT PAID AFTER THE 35 DAYS FROM THE PREVIOUS MONTH'S STATEMENT DATE, WILL BE CHARGED TO. NO SOCIAL MEMBER ACCOUNT NUMBER WILL BE ASSIGNED UNTIL SUCH CREDIT CARD NUMBER IS RECEIVED IN THE OFFICE.
- E. ALL HOUSE ACCOUNTS ARE DUE AND PAYABLE BY THE LAST DAY OF THE MONTH IN WHICH THE STATEMENT IS RECEIVED. INTEREST OF 2% PER MONTH WILL BE CHARGED ON ALL OUTSTANDING ACCOUNTS AFTER THE SIXTH DAY OF THE MONTH FOLLOWING THE STATEMENT DATE.

FAILURE TO PAY IN FULL ALL OUTSTANDING HOUSE ACCOUNT BALANCES BY THE 8TH DAY OF THE MONTH FOLLOWING THE BILLING MONTH WILL RESULT IN CHARGE PRIVILEGES BEING SUSPENDED. **AT ANY POINT IN THE SEASON, IF A SOCIAL MEMBER HAS AN OUTSTANDING BALANCE PAST 60 DAYS, OR HAS NOT PAID THEIR FULL BALANCES BY DECEMBER 31, THEIR APPLICATION WILL NOT BE CONSIDERED FOR THE FOLLOWING SEASON.**
